PURPOSE:

The purpose of the application is to re-establish four previously existing lots which have inadvertently merged in title. The effect of the application will create a total of four shoreline residential lots with lots areas of 1.3 hectares, 1.0 hectares, 1.4 hectares, and 1.6 hectares. The proposed lot with a lot area of 1.6 hectares will contain an existing detached dwelling, bunkie and shed; and the other three lots will be vacant.
