

Dear Members

Thank you for the prompt reply to my letter of January 8, 2016, however some of my letter has been taken into wrong context or answered incorrectly.

1. Community Centre answer to my question was that the Centre is not closing. I did not say that it should close but to take heed what happened in Cobalt. The expenses for this centre are climbing and climbing however revenue is going down. I suggest you take a better look at expenses and be more cautious and control spending. The losses for the years I have asked for seem very high.

2. My letter stated that I think the location set out for the new docks needed to be addressed as to proper location. My answer that I got was that to change any plans now was not feasible due to the approved process by MNR in 2007. After checking with the MNR in North Bay I was told there are no permits required by individuals nor Municipality of Temagami to put in floating docks. My concern for where they are going is cost and time .
3. The Jail-----The answer I received was basically the Municipality of Temagami is not interested into looking into this as the resources for infrastructure, labour and housing is not there. I am sure that if we went to bat for this facility the housing labour force etc. would happen. . Also reply stated that the former Economic Development Officer had reviewed this issue with Community Safety and Correctional Services and stated that Temagami is not an ideal location. I have been in communication with the Community Safety and Correctional Services who told me that they had no interest from the Municipality of Temagami regarding this. They put me on to the Deputy Regional Director who told me they had no knowledge of any of this and further said any involvement by any municipality would have to go through the MPP office. I called

John Vanthof's office and they have no knowledge of Municipality of Temagami looking into this. Therefore leaving me think ????????????. All I am saying that this might be a good thing to look into to give this community a boost.
