

# THE CORPORATION OF THE MUNICIPALITY OF TEMAGAMI

## BY-LAW NO. 10-898

---

**Being a by-law to amend Schedule A of By-law No. 10-870 the by-law to regulate the keeping of animals and the registration of dogs and cats in the Municipality of Temagami.**

---

**WHEREAS;** in accordance with Section 391(1) of the Municipal Act, S.O. 2001, Chapter M. 45 as amended, a municipality may impose fees or charges on persons for services or activities provided or done by or on behalf of it;

AND WHEREAS the Council of the Corporation of the Municipality of Temagami passed By-law No. 10-870 which provides for dog and cat licenses / tags to be issued for an animal's lifetime rather than an annual licence and tag;

AND WHEREAS the Council of the Corporation of the Municipality of Temagami deems it advisable to amend Schedule A of By-law No. 10-870 to amend the fees charged for such licenses / tags;

NOW THEREFORE the Council of the Corporation of the Municipality of Temagami hereby enacts as follows:

1. That section 5.1 (f) of By-law 10-870 be deleted and replaced by the following:
  - (f) shall pay a registration fee to register the dog or cat as outlined in schedule A of this bylaw.
  
2. That section 5.1 (g) of By-law 10-870 be deleted and replaced by the following:
  - g) The registration fee otherwise payable by an owner to register a dog or cat will be reduced by an amount as set forth in Schedule A to this bylaw, provided the applicant provides at the time of registration, evidence satisfactory to the Registrar of the following:
    - a) the owner of the dog or cat is 65 years of age or older; or
    - b) the dog or cat has been spayed or neutered. A certificate signed by a veterinarian shall be satisfactory evidence, but the Registrar may accept such other evidence as the Registrar in his or her sole discretion may determine.
  
3. That Schedule A of By-law 10-870 be deleted and replaced by the Schedule A attached hereto;
  
4. That this By-law shall take effect on the final passing thereof.

BE TAKEN AS READ A FIRST time on this 28<sup>th</sup> day of January, 2010;

READ A SECOND TIME on this 28<sup>th</sup> day of January, 2010;

READ A THIRD TIME AND FINALLY PASSED on this 28<sup>th</sup> day of January, 2010.
